

CHAPTER V

CONCLUSION AND SUGGESTIONS

This chapter presents: (1) conclusion, and (2) suggestions.

In this chapter, all of the result from finding had been concluded. I also presented the suggestions that were expected to be useful for the school, teachers, students, and other researchers.

5.1 Conclusion

Based on the result of data analysis by using thematic analysis, I found that there were some students who became demotivated in English language learning at MTsN 1 Palembang. The research problem was to find out the students' demotivating factors in English language learning at MTsN 1 Palembang. All the data were obtained from reviewing the document of students' English achievement and from interviewing the participants involved. I found that there were five factors that affected students' demotivating in English language learning, as follow: (a) inadequate school facilities, (b) lack of teachers' competence and teaching style, (c) teaching materials and contents, (d) classroom condition and classmates' attitudes, and (e) lack of self-confidence.

5.2 Suggestions

Based on the findings of this research, there are some suggestions provided for the school, the English teacher, and the students. The first suggestion is to improve the school facilities, especially the electricity. Then, each class must be having fresh air circulation and a good lighting. A bad

condition can make the students feel hot and cannot concentrate well in English language learning. Certainly, adequate learning facilities such as fans, in-focus, and speaker will make students more enthusiastic to learn in their classroom.

Additionally for the English teacher, it is expected that English teacher can improve the way they teach by using various teaching styles and materials, such as giving warming up for students or introducing them the material, playing a game for the question and answer session, using listening audio or watching educational movies.

Last, the researcher expected that the students can find out the strategy that can avoid the factors that demotivated them. Then, the students should practice more at their home, for instance listening English songs, watching movie with using the English subtitle, learn how to be a confident students because a mistake is the part of learning, the students can bring a mini portable fan and put it on their table, or anything that can make them feel more enjoy in learning English.
